E-TENDER NOTICE

Subject: The work of erection of pendal, stage, catering services and supply of other amenities for inaugural, prize distribution function and workshop for 23rd Exhibition cum Workshop on Horticulture to be held at V.J.B. Udyan, Byculla from 9th to 11th February 2018.

The Municipal Corporation of Greater Mumbai (MCGM) invites e-tender on item rate basis to appoint Contractor for the aforementioned work from contractors fulfilling the following eligibility criteria:

1. The tenderer shall have carried out at least one similar type of work amounting to Rs.5 lakhs in M.C.G.M., State Govt. or semi-Govt. organization during last six years. Tenderer shall upload performance/work completion certificates as a proof for the same.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

- 2. Achieved an average annual financial turnover as certified by 'Chartered Accountant' equal to 30% of the estimated cost of work in last three (3) financial years immediately preceding the Financial Year in which bids are invited. Tenderer shall upload the acknowledgment receipts of income tax returns as a proof.
- 3. The tenderer shall have cleared their service tax for last three years and filed their service tax returns for the period (I) October 2014 to March 2015 (ii) April 2015 to September 2015, (iii) October 2015 to March 2016, (iv) April 2016 to September 2016, (v) October 2016 to March 2017 and (vi) April 2017 to June 2017. Tenderer shall upload the acknowledgment receipts of service tax returns as a proof.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from MCGM's portal (http://portal.mcgm.gov.in) on payment of amount equal to 0.07% of office estimated cost (rounded to hundred digit) with addition of GST (i.e. minimum Rs. 210/-+ GST &

maximum Rs.7000/- + GST). The applicants not registered with MCGM are mandated to get registered(Vendor Registration) with MCGM for e-tendering process & obtain login credentials to participate in the online bidding process.

- ii) Followed by SRM login ID and password to be obtained from Central Purchase Department (CPD), Office at Byculla, Bakariadda, Mumbai
- iii) For e-Tendering registration, enrolment for digital signature certificates and user manual, please refer to respective links provided in 'Tenders' tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics center, TCS, CUSTOMS, MTNL, GNFC and e- Mudhra CA.

found acceptable to the Authority.

G.S.T. and other State levies/cess which are not subsumed under G.S.T. will be applicable.

The tenderer shall quote inclusive of all taxes. It is clearly understood that M.C.G.M. will not bear

any additional liabilities towards payment of any taxes and duties.

Wherever the services to be provided by the tenders falls under Reversed Charged

Mechanism, the price quoted shall be exclusive of G.S.T., but inclusive of Taxes/Duties/Cess other

than GST if any.

Rates accepted by MCGM shall hold good till completion of work and no

additional individual claim shall be admissible on account of fluctuations in market rates,

increasing taxes/any other levies/tolls etc. except that payment/recovery for overall market

situation shall be made as per price variation. As per opinion received from consultant, 18%

G.S.T.will be applicable for the said work.
