TERMS of REFERENCE For Empanelment of Troops for Street Theatre

[A] Introduction:

'Child Protection' is about protecting children from or against any perceived or real danger or risk to their life, their personhood and childhood. It is about reducing their vulnerability to any kind of harm and ensuring that no child falls out of the social safety net and that those who do, receive necessary care, protection and support so as to bring them back into the safety net. While protection is a right of every child, some children are more vulnerable than others and need special attention. The Government recognizes these children as 'children in difficult circumstances', characterized by their specific social, economic and geo-political situations. In addition to providing a safe environment for these children, it is imperative to ensure that all other children also remain protected. This is because Child protection is integrally linked to every other right of the child.

The Integrated Child Protection Scheme (ICPS) has significantly contributed to the realization of Government/State responsibility for creating a system that will efficiently and effectively protect children. Based on the cardinal principles of "protection of child rights" and "best interest of the child", ICPS is achieving its objectives to contribute to the improvements in the well being of children in difficult circumstances, as well as to the reduction of vulnerabilities to situations and actions that lead to abuse, neglect, exploitation, abandonment and separation of children from their families.

The Scheme, since its launch in 2009, in partnership with the State Governments/UT Administrations, has strengthened prevention of child rights violation; enhanced infrastructure for protection services; provided financial support for implementation of the Juvenile Justice (Care and Protection of Children) Act, 2000; increased access to a wider range and better quality of protection services; increased investment in child protection and is continuously drawing focus on the right of all children to be safe.

[B] Eligibility:

- Must be a registered organization under Society Registration Act or Trust Act.
- Must have experience in conducting Street Theatres for mass awareness. Preferable in executing mass awareness program on Govt. Schemes & Programs.
- Must have willingness to attend a 3 days Capacity Building Workshop for concept clarity and script development.
- PAN Card and Service Tax Clearance [if any]



[C]How to apply:

The interested and eligible troops may send their proposal along with the supporting documents and application in the prescribed format to the "The District Child Protection Unit , At-Municipality Sahi , Po/Dist-Deogarh , Pin-768108" through Speed Post / Registered Post within the date as stated & stipulated in the advertisement.

[D]Prescribed form : Attached as "ANNEXURE-3".

[E]Selection Procedure:

[a]Screening of Proposals & Supporting Documents by the Dist. Screening Committee.

[b]Demonstration by the shortlisted troops before Dist. Selection Committee / Jury.

N.B: The decision of the Selection Committee & approval of Collector & DM , Deogarh will be final .

[F]Terms & Conditions:

- The duration of the show must not be less than 45 minutes.
- Invite public representatives for inauguration of the program.
- The Script of the Street Play must cover the following topics in clear & innovative way such as [a]Definition of Child as per JJ Act , [b]Target Group of ICPS , [c]Stakeholders & Child Protection Committees in Various level , [d]Statutory Bodies & Services in ICPS , [e]Elimination of Child Labour , Prohibition of Child Marriage , [f]Adoption of Abandoned , Orphan & Surrendered Children , [g]Provision under ICPS for Institutional Care , Non-Institutional Care & Emergency Service , [h]Shishu Mitra Panchayats.
- All the program must be performed on the mentioned topic as per the approved script and performance beside topic / script is not permissible.
- The organization has to submit 3 copies of scripts for approval.
- The program will be organized in GP/Block/Dist. HQ in the morning & evening session.
- A Register will be maintained in which signature of viewers must find place along with views of local eminent personalities or functionaries.
- Documentation in shape of steel photographs [1 nos. for each program] with banner , a printed consolidated report reflecting schedule of the performance and a Video CD reflecting the highlights of each program to be submitted in both hard & soft form.
- The unit cost includes all charges for the program including documentation, logistic , travel of troop , sound & light system etc..However 2 nos. of Banner for vehicle and 1 no. of Banner for the spot along with leaflets for distribution will be provided from DCPU , Deogarh.
- Payment will be made after successful completion of the program with production of [a] Consolidated Report , [b]Utilization Certification by the Institution , [c]Steel Photographs , [d]Video CD , [e]Registration Register.
- The selected troop must have willingness to attend a Concept Clarity and Script Development Workshop for 3 days [Residential] . Before execution of the assignment, the troop have to present a demonstration before the selection committee / Jury.
- DCPU , Deogarh will not be responsible for any mishap to the troop during performance.
